
#### VII. Fee Schedule – enter the number of items being installed, multiply by the unit price for total fee.

New houses require #1, #2, #24 and #25. Inspections require separate fees.

Item #3 – Water Heater is a flat fee of \$130. No application fee required.

The Application Fee is NON-REFUNDABLE and DOES NOT include any inspections.

Item # 27 – Mobile Home Unit Site: When item is used for sewer excavations in a new park, the permit application should include the Application Fee plus the number of Unit Sites. When setting a mobile or modular home on a private property, a permit should include the Application Fee, a Sewer or Bldg. Drain and a Water Service or Water Distribution Pipe.

<b>GENERAL</b> : Any regulated activity started prior to the applicant securing the permit will be charged an additional administrative charge at the same rate as the required permit fee not to exceed \$100.00. This shall be paid prior to the issuance of the required permit.	<b>PERMIT EXPIRATION</b> : A permit remains valid provided work is progressing & inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within 6 months of issuance of the permit or if work is suspended or abandoned for a period of 6 months after the time of commencement. A permit will be cancelled when no inspections are requested and conducted within 6 months of the date of issuance or the date of a previous inspection. Cancelled permits cannot be refunded or reinstated.
